## IowaDocs 2019 Installation Procedure for Desktop Users

Below are the instructions on updating your current version of IowaDocs to the newest version for the Desktop.

There are two parts to this process:

- Part 1: Removing IowaDocs 2018 contents
- Part 2: Downloading the current update file from HotDocs Market and installing it.

If you have individual libraries, each computer will need to follow all of these steps, unless you share the file downloaded in Part 2 with other users, they can skip the downloading steps (#10-#12).

If you have a network install be sure all users are completely out of IowaDocs/HotDocs before you continue with the steps below.

## Part 1: Removing IowaDocs 2018 contents

- 1. Open your current lowaDocs library
- 2. If needed, collapse all your folders by clicking on the "View" menu and select "Collapse All". (see "Figure 1")

- 3. Click on the first item in the library (for most that will be "Attorney and Preparer Information"). (see "Figure 2")
- 4. Hold the "Shift" key on your keyboard down, and click on the last item listed (for most that will be the folder entitled "Workers Compensation Forms"). (see "Figure 2")

5. Click on the "Edit" menu and select "Remove Item" from that menu. (see "Figure 3")

10. Open your web browser and visit <u>www.hotdocsmarket.com</u> and sign in with your primary account holder. (see "Figure 5")

11. Go to "My Subscriptions" click on the word "IowaDocs" listed under your subscriptions. (see "Figure 6")

12. Click on "Download HDI" to the right of the library listing. If asked to save or open - you may select either but it is recommended that you select "Save". (see "Figure 7")

(By default, this file will download to your "Downloads" folder so you may need to visit that location to run this file once it has completed downloading)
